

The other reviewers rated this study guide pretty well so I decided to give it a try and see how well it compares to the competition. At first glance it is smaller in size than the ones from LSAC. In fact only a 140 pages... so I was a little apprehensive of how effective this guide will be. However, all of my concerns are quickly put to rest as I start reading the content. I like how they just go right into it not wasting any time with extra nonsense or fluff. They start off with test taking strategies and go right into how to approach the questions on the LSAT. For me I feel this book approaches everything from a real world perspective. Other books are kind of confusing, which is exactly what the LSAT is trying to do! Time will tell if my score is good enough. But for now, I feel like I am progressing and getting more questions right when I do practice tests.

I thought that this study guide provided a great overview of the LSAT. The explanations for the Analytical Reasoning Exercises were especially helpful. The only thing I would suggest for improvement would be to add a full length test at the end.

I have yet to take the LSAT (taking it in June), but this book is excellent for learning about the different types of questions! It has a section about each LSAT section with practice questions and answer explanations at the end. I also have an LSAC book of practice tests and the SuperPrep, and this supplements those perfectly.

This book is a great starting point for those who are interested in going to law school. It's easy to understand and not intimidating. At 140 pages, this guide highlights the main points in each of the sections, test taking strategies and time saving techniques but you'll need to invest in practice tests to hone your skills. Not saying this is the end all be all but this is definitely a good basic review and great confidence booster.
