

Kelleher Centennial Professor of Business Law at The University of Texas at Austin Law School, where his research centers on judicial decision-making, the economics of law and litigation, and traditional policy and doctrinal issues in administrative law. He has written several books as well as pieces for the Yale Law Journal, Columbia Law Review, University of Chicago Law Review, New York University Law Review, Texas Law Review, Virginia Law Review, Cornell Law Review, Georgetown Law Journal, Northwestern Law Review, and UCLA Law Review. A former president of the Academy of Legal Studies in Business, Professor Cross received his B.A. from the University of Kansas and J.D. from Harvard Law School. Roger LeRoy Miller, Ph.D. has served on the faculty of several universities, including the University of Washington, Clemson

University, and the University of Miami School of Law. As a professor, he has taught intellectual property law and entertainment law, among other subjects. This book explained in better detail things that other textbooks failed to. The cases that they note under different topics really help to grasp the concepts. I had to purchase this for a legal class in my MBA program. I have to say that I was pleasantly surprised. The material was easy to absorb, even for someone with little pre-knowledge of law. It served as a wonderful overview, providing high level detail that is easily searched using the index. The case studies are good illustrations of the points within the chapters. The questions at the end give the student or reader the ability to apply what is learned in the previous chapter.
