


The book was found

Synopsis

Dale Johnston was arrested, tried and convicted for the dismemberment murders of his stepdaughter, Annette Cooper, and her fianc  , Todd Schultz. He was sentenced to die in the electric chair. His conviction by a three-judge panel was later reversed by the Ohio Court of Appeals and that decision was subsequently upheld by Ohio's Supreme Court. However, the original question still remained: Was there a reasonable doubt?
