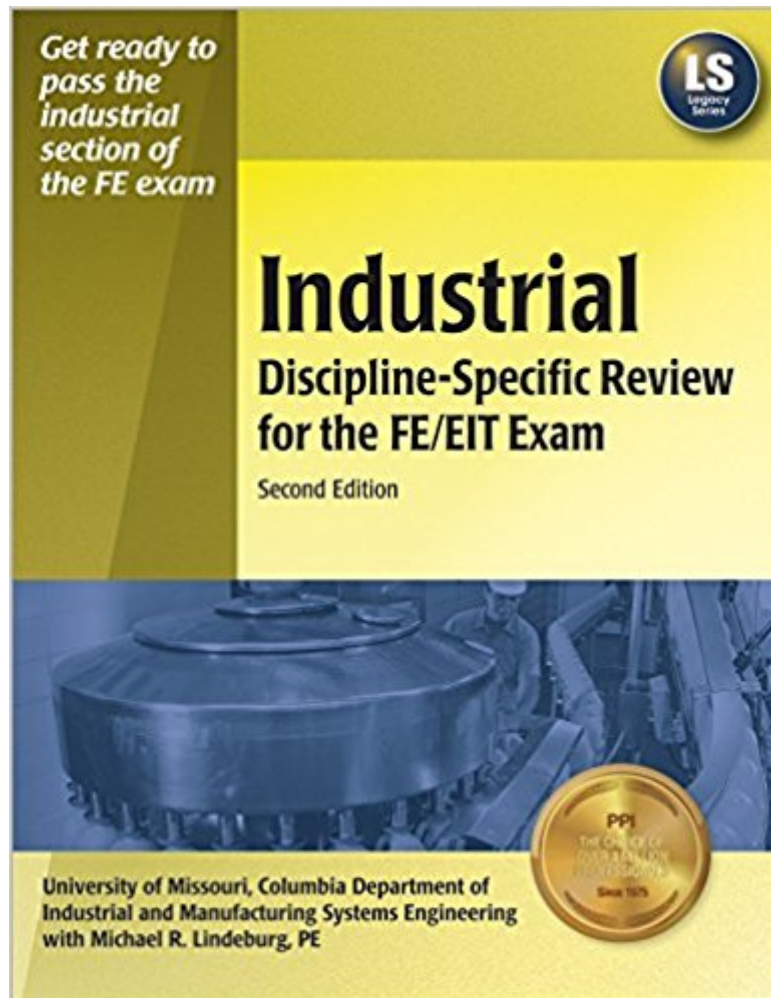

Good tools practice

I have taken and passed (on my first try) the FE in industrial Engineering in NY on October 9, 2015. I found this booklet useful for the most part as some of the questions on the actual test were similar to the first practice test located on the back of the booklet. I found the second practice test to be more difficult than the test questions and when I took it a few days before the exam I ended up failing badly. If you are going after the FE in Industrial this should not be your primary source of study as NCEES has recently updated the format of the FE exam. However, the material in this booklet was useful in that it pointed me in the right direction of the sample questions that may be asked in the test. Also, the practice test where a good time control measure. This is not a book and there are no chapters detailing the theory of industrial practices and subject topics which, initially, left me frustrated and was a big letdown. As my primary source of studying I used Operations Management by Hazier and Render the 9th edition published in 2007. I thought that Quality, Work, Facilities, Project Management, and Manufacturing topics of the exam are well covered with ample sample problems. These are 5 of the 13 topics on the test. For Mathematics, Probability and Statistics, and Economics I used the original Lindeburg review book (the one that contains all the topics of the previous/general FE exam). I ended up not studying the Engineering Sciences topic of the test as there were only 5 potential questions to be asked and the subject topics are broad, though I ended up getting most of the questions right on the test. The final source of study was the Industrial Engineering prep book by Kaplan. I opted for the online desktop version which I was happy with for the most part. The Systems Engineering topic is well defined which was very helpful. The reality is that there are not many studying sources for Industrial Engineers and even though this booklet is lacking it is still a good test source to have. Good luck to all who are going after the FE in Industrial. I did about 6 weeks of solid studying - probably somewhere between 100-150 hours in total. I have been out of school for 4 years so I needed to revisit all the material

but if you are just graduating you can probably do with less.

Just wanted to point out this book is outdated and hasn't kept up with the exam specifications. There is no material on Engineering Sciences, for example. It is probably helpful enough on other topics, but needs to be updated. There isn't a lot out there on this exam, so options are limited.

It has been my partner on the journey to get the approval on the FE Test, specially in the Industrial section of the test. It is an awesome collection of questions, pretty helpful to study and do a great review for the test. I was expecting for more questions in a thicker book, but this one covers all possible fields.
