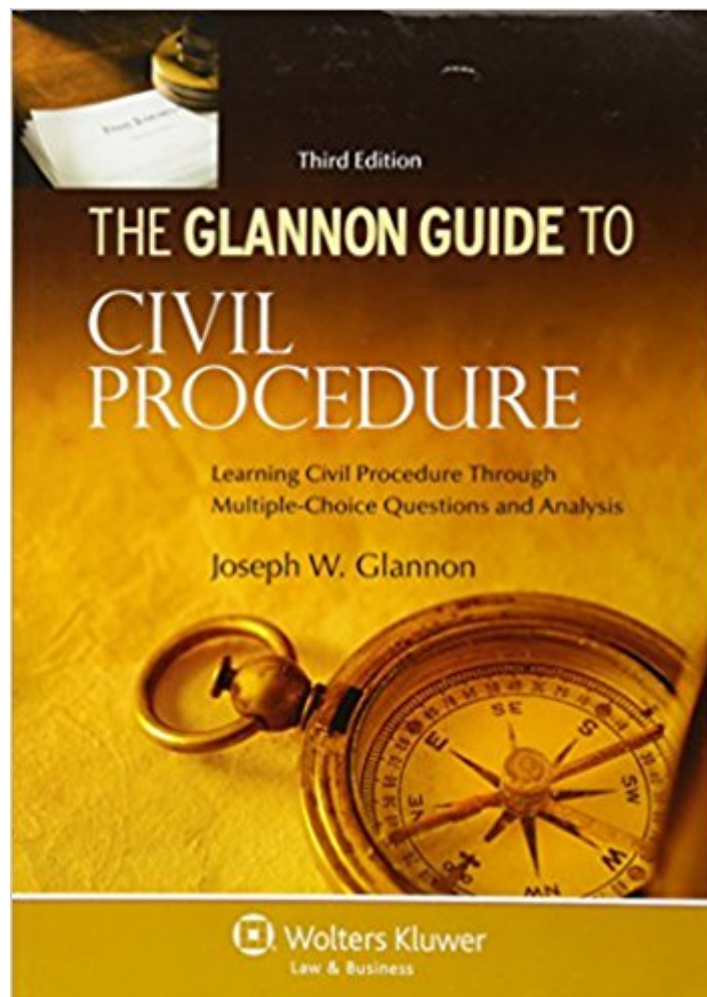

If I could give this zero stars, I would. I thought my professor made civil procedure confusing and this is even more unclear than his class was. The questions that are supposed to help you understand that material are poorly drafted and some of the answers are even worse. Civil Procedure is such a hard class, and I realized that I needed to look for some other form to learn the material.
